Surveillance Recording and Monitoring

Florida Nonprofit Security Grant Program (NSGP)

1. Introduction

The Jewish Community of Manatee County, DBA Temple Beth El, is seeking proposals from qualified and licensed security firms to provide **armed security** for our facility located at 5150 Peridia Blvd. East, Bradenton, FL 34203 and other locations TBD within Manatee County. This project is funded under the Florida Nonprofit Security Grant Program (NSGP).

The purpose of this RFP is to ensure proper surveillance, indoors and outdoors to enhance the safety and protection of attendees, staff, and property.

3. Scope of Services

The selected vendor shall provide:

- Install recording, monitoring and data storage from video feeds from various locations on the inside and outside of facility.

Recording equipment

- Be capable of being connected via wi-fi connections or hard wiring.
- Capture video images from all vantage points from within facility and complete coverage of surrounding outdoor areas simultaneously.

- Store and maintain recorded footage for a period of 7 days.
- Provide remote access to all cameras using portable devices such as cell phones and tablets.
- Be able to produce images with quality comparable to, or better than 4K resolution, for easy identification of captured frames 24 hours a day.
- Be mounted to a concrete and wood constructed building with hardware capable of withstanding weather conditions conducive to the Florida southwest Gulf area.
- Installation and secure mounting of cameras at designated locations using appropriate electrical enclosures, specialty brackets, and weatherproofing solutions to ensure long-term performance and protection. Cable ends will be properly terminated per EIA/TIA 568 Standards.
- No equipment specified may be on the Federal Governments list of prohibited manufacturers. See footnote at end of RFP

Cabling

Installation of structured network cabling for security cameras, including routing through walls, ceilings, and floors as necessary. All cabling will be installed per ANSI/TIA, EIA, and ISO standards, properly labeled, and supported according to NEC (National Electrical Code) requirements. Proposal assumes all cable runs to cameras are in compliance with distance limitations based on switch type (325' for standard PoE devices or 700' when using an SCW device with extended transmission).

NVR Provisioning & Networking

Installation of the Network Video Recorder (NVR), switches, patch panels, and all necessary networking equipment at the agreed-upon location. Established connectivity to our ISP will be provided. We will provide adequate rack or wall space for the physical security equipment, along with access to sufficient power.

4. Insurance Requirements

Vendor must maintain:

- General Liability Insurance: Minimum \$1,000,000 per occurrence
- Professional Liability (if applicable)
- Certificate of Insurance must list The Jewish Community of Manatee LLC as Certificate Holder.

5. Reporting & Documentation (NSGP Compliance)

Vendor must provide:

- Documentation sufficient to meet Florida Division of Emergency Management reimbursement standards

6. Proposal Submission Requirements

Proposals must include:

1. Company profile and years in operation
2. Insurance certificates
3. Be registered with SAM.gov
4. Submit plans with images showing the position of recording equipment and areas of coverage.
5. Completed and approved building permits from local governing authorities if applicable.

7. Evaluation Criteria

Proposals will be evaluated based on:

- Licensing and compliance (mandatory)
- Cost competitiveness
- Professional references
- Ability to meet NSGP documentation requirements

9. Term of Agreement

The contract term shall cover the specified dates for a mandatory site visit, installation, final evaluation by issuing facility authorized representative, specified completion date met, completed and approved and closed out building permits by local governing authority.
